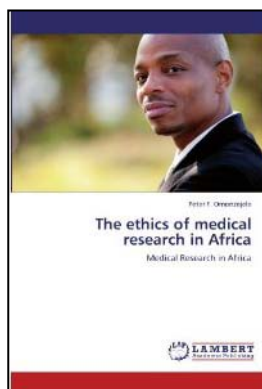

Our newsletter editor and research assistant **Cathy** left the University to pursue other opportunities. Local and international colleagues miss her involvement in the Centre.

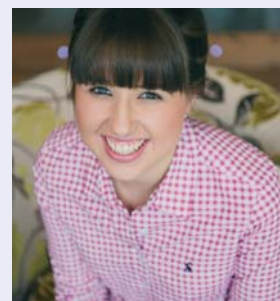

Meet our Collaborators: Prof. Rachel Wynberg



Rachel Wynberg is an academic, activist and policy adviser with a special interest in biodiversity use and benefit sharing, community rights, social justice and environmental governance. She holds a South African Research Chair on Social and Environmental Dimensions of the Bio-economy at the University of Cape Town (UCT), where she is associate professor in the Department of Environmental and Geographical Science. Over the past twenty years Rachel has advised governments, civil society organisations and international agencies on biodiversity issues and continues to be actively involved with NGOs in the region, serving on the Boards of Bio-watch South Africa, Environmental Monitoring Group, and PhytoTrade Africa. Rachel has been collaborating with the Centre since 2004, including on two funded projects (Wellcome Trust, EU) and one book.

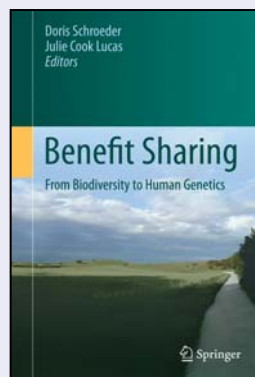

ProGRess—New 1.5 million EU Project Launched

In 2013, the Centre launched a new EU-funded project: ProGRess (progressproject.eu, Youtube: <http://bit.ly/1dKXIZa>). The three-year project includes partners from all continents and funds a global network on Responsible Research and Innovation.

The project has already made good progress on one of its main deliverables: the preparation of reports from Europe, the US, China, Japan, India, Australia and South Africa on the way governments drive innovation towards societally desirable goals.

One of the project's most exciting events will be a workshop in Kimberley, South Africa, on "San Knowledge and Innovation", which links to earlier work undertaken in the Centre on benefit sharing. In collaboration with the University of Cape Town (see also page 3, on our UCT collaborator) and the South African San Institute, the workshop will examine how marginalized communities can provide meaningful input into innovation systems.

GEST—EU Project Entering its Final Phase



GEST Meeting at the Chinese Academy of Science and Technology for Development

The GEST project (Global Ethics in Science and Technology Policy) is reaching its final stage. The project includes a group of academics and policy advisors from Europe, China and India who focus on the incorporation of ethical issues in policy making about new technologies.

Case studies on genetically modified foods, nanotechnologies and synthetic biology have been analysed in the three regions in terms of innovation, risk and legislative debates deriving from ethical issues. Two main dissemination events are scheduled in Delhi, India and in Brussels at the European Parliament later in 2014. In 2015, results from the project will be published in an Open Access book.
